ORDER

1. The provisional affiliation for starting B.Ed. degree programme at Bharatheeya Vidya Nikethan College of Teacher Education, Kallekkad, Palakkad was granted during the academic year 2009-10 with an intake of 100 students vide U.O. read as 1st and addition of a new optional subject, i.e., Sanskrit, was sanctioned by reducing the number of seats in the existing optional Social Science from 30 to 15 seats during the academic year 2015-16, vide U.O. read as 2nd above. Sanction was accorded, vide U.O. read as 3rd, for granting redistribution of seats in the optional subjects in the B.Ed. programme from the academic year 2015-16 onwards in the College as per the B.Ed. admission prospectus 2015-17.
2. As per the NCTE Regulations 2014, vide paper read as 4th above, the B.Ed. programme shall be of a duration of two academic years, and the intake shall be a basic unit of 50 students, with a maximum of two units. The NCTE has permitted the College, vide paper read as 5th above, for conducting B.Ed. programme of 2 years' duration with an annual intake of 100, for two basic units of 50 students each from the academic session 2015-16 onwards.
3. As per U.O. read as 6th above, permission has been granted to consider the applications received from the training colleges at the beginning of each academic year (from 2017-18 onwards) as in the case of other courses and grant continuation of provisional affiliation, without insisting orders for extension of approval from the NCTE.
4. Permanent seat distribution was sanctioned to B. Ed. programme w.e.f. the academic year 2020-'21 along with re-arrangement of seats for 2020-'21, vide U.O. read as 7th. Continuation of provisional affiliation, granted conditionally to B.Ed. degree programme at Bharatheeya Vidya Nikethan College of Teacher Education, Kallekkad, Palakkad with a total intake of 100 students, was regularised with revised seat distribution for the academic year 2020-'21 vide U.O. read as 8th.
5. The Principal, Bharatheeya Vidya Nikethan College of Teacher Education, Kallekkad, Palakkad had applied for continuation of provisional affiliation to B.Ed programme for the academic year 2021-'22 vide paper read as 11th and remitted an amount of ₹.1,65,375/- (Rupees One Lakh Sixty Five Thousand and Three hundred and Seventy Five only) towards administration and affiliation fee vide chalan No. 202063116 dated 30.11.2020. The Principal has submitted necessary documents along with the application which have been insisted in the U.O. and Circular read as 9th & 10th.

6. As per the G.O. read as 13th above, the Higher Education Department, Govt. of Kerala renewed NOC for conducting Self Financing B. Ed. programme at Bharatheeya Vidya Nikethan College of Teacher Education, Kallekkad, Palakkad for the year 2021-'22.

7. Considering the above, sanction has been accorded by the Vice Chancellor on 19/10/2021, for granting continuation of provisional affiliation to B.Ed. programme with an intake of 100 students (50 x 2 units) as shown below, at Bharatheeya Vidya Nikethan College of Teacher Education, Kallekkad P.O., Palakkad (Unaided), for the academic year 2021-'22 and subject to the terms and conditions specified thereunder.

8. The Principal is directed to strictly adhere to the NCTE Regulations in respect of qualification of teaching faculties prior to submission of application for Continuation of Provisional Affiliation for 2022-'23.

9. The affiliation granted is strictly provisional and only for the academic year 2021-'22. The College has to apply for continuation of provisional affiliation for the ensuing academic years by remitting the fee fixed by the University.

10. The selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

11. Conduct of University Examinations of any sort including that of SDE Examinations are compulsory and binding on all colleges affiliated to the University of Calicut.

12. The list of colleges which have renewed their provisional affiliation will be forwarded to the Office of the Controller of Examinations to see that examinations are not conducted in those colleges which have no valid affiliation orders.

13. In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college shall be initiated.
