ORDER

- Provisional affiliation for starting B.Ed. programme at Bharatheeya Vidya Nikethan College of Teacher Education (Un-Aided), Kallekkad, Palakkad was granted during the academic year 2009-10 with an intake of 100 students vide U.O. read as (1). Addition of a new optional subject, i.e., Sanskrit, was sanctioned by reducing the number of seats in the existing optional subject, Social Science, from 30 to 15 seats during the academic year 2015-16, vide U.O. read as (2).
- The NCTE permitted the college for conducting B.Ed. programme of 2 years duration with an annual intake of 100, for two basic units of 50 students each w.e.f. the academic session 2015-16, vide paper read as (3).
- Permission was granted to consider the applications received from training colleges at the beginning of each academic year (from 2017-18 onwards) as in the case of other programmes and to grant continuation of provisional affiliation, without insisting orders for extension of approval from the NCTE, vide U.O. read as (4).
- Permanent seat distribution was sanctioned to B.Ed. programme at the College w.e.f. 2020-'21 academic year, vide U.O. read as (5). Continuation of Provisional Affiliation was granted for the academic year 2024-25, vide U.O. read as (6).
- The Principal has submitted application for Continuation of Provisional Affiliation to the self financing B.Ed. programme for the academic year 2024-'25, vide paper read as (7).
- Considering the matter in detail, sanction has been accorded by the Vice Chancellor to grant Continuation of Provisional Affiliation to the Self financing B.Ed. programmes with an intake of 100 students (50 x 2 units) at Bharatheeya Vidya Nikethan College of Teacher Education (Un-Aided), Kallekkad, Palakkad as detailed below for the academic year 2025-26 conditionally, subject to submission of NOC from Government of Kerala and with strict directions to comply with the norms prescribed by the NCTE, while engaging faculties.

7. Orders are issued accordingly subject to the following terms and conditions:

- i. The Principal shall strictly follow the syllabi, available on the University website (www.uoc.ac.in).
- ii. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
- iii. In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the institution shall take stringent measures for the prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- iv. Affiliation granted is strictly provisional and only for the academic year 2025-26. The college shall apply for CPA for the ensuing years remitting the fee fixed by the University, along with the extension of approval orders, if any, from the apex bodies concerned.
- v. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
- vi. The conduct of University Examinations of any sort including that of the SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- vii. The college is liable to comply with the general conditions stipulated in the renewed NOC from the Government of Kerala for the academic year.
- viii. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- ix. Violation of any of the above will lead to the cancellation of affiliation.


